# **UROLOGIST**

The Urologist provides quality patient centered urology service at the Cayman Islands Hospital shared with other Consultant Surgeons, Registrars and Clinical Interns rotating throughout the H.S.A.

Primary Responsibilities: The successful candidate will provide comprehensive 24-hour urology services, including one weekend per month in collaboration with private urology providers. Responsibilities include conducting regular general urology outpatient clinics, ward rounds, and providing support to Accident and Emergency staff, as well as managing patients in the Critical Care Unit when appropriate. The role also involves monthly outpatient clinics and operating room procedures at Faith Hospital (Cayman Brac). Working closely with colleagues across disciplines, the successful candidate will contribute to the development of evidence-based clinical guidelines and care pathways for urology services. Additional duties include participation in continuing professional development, clinical audit, and quality improvement initiatives; involvement in strategic surgical service planning; and the establishment of educational programs for nursing and allied health staff. The successful candidate will also collaborate with health agencies to promote disease prevention and health awareness and will actively participate as a member of the Medical Staff Committee, Clinical Quality Committee, and Pharmacy and Therapeutics Committee.

**Qualification & Experience:** The successful candidate must hold a primary medical qualification registered in Canada, the United States, the United Kingdom, or Jamaica, along with a minimum of four (4) years of accredited training in general surgery. A recognized postgraduate qualification such as FRCS, MD, Board Certification, or an equivalent credential is required. Candidates should also possess at least seven (7) years of postgraduate experience in urology or a related specialty relevant to the services provided.

In addition to a *tax-free salary*, we provide full healthcare coverage at no cost to employees, pensions plan, paid holidays, annual leave, training leave, initial and annual licensing fees paid by HSA, malpractice coverage on hospital corporate plan. Relocation package includes air passage, and freight for employee and dependent (s) to the Cayman Islands.

A remuneration and benefits package, commensurate with experience and qualifications will be offered to the successful candidate.

### **Background Information**

The Cayman Islands Health Services Authority ("HSA") provides and administers health care services and public health functions for residents of the Cayman Islands in accordance with the National Strategic Plan for Health.

Services are delivered primarily through the 127-beds at the Cayman Islands Hospital (the country's principal health care facility), and the 18-beds at the Faith Hospital on Cayman Brac. Ancillary services are offered at district health centers, and clinics for dental and ophthalmologic care. Residents of Little Cayman can access care through the island's clinic which is a purposebuilt facility.

# Job purpose

To provide a quality patient centered urology service at the Cayman Islands Hospital, Grand Cayman, shared with other Consultant Surgeons, Registrars and Clinical Interns rotating throughout the H.S.A.

Work is generated by patients referred by other consultants and the Accident and Emergency Departments. Patients transferred from General Practice Clinics. Patients referred from private practitioners.

The postholder is expected to refer patients to other disciplines within the government health service, or to tertiary center, where this is indicated by the clinical needs of the patients.

Liaise closely with colleagues in other clinical disciplines.

#### **Dimensions**

The principal specialties are provided by the C.I. Health Service Authority. Those requiring tertiary referral to Miami include neurosurgery, specialist pediatric surgery, thoracic and vascular surgery, with some requiring air ambulance transfer. The 8 CCU beds, enable more critically ill patients to be retained on the island.

As the only Urologist on island, clinical competence and experience in both acute and chronic nonemergency urology is a necessity. The postholder is responsible for the clinical care of urology admissions, specialist clinic and operating room.

The postholder has no budgetary responsibilities.

### **Duties and responsibilities**

To provide a 24-hour urology service with assistance from private Urology one weekend per month.

To provide regular general urology outpatient clinics and ward rounds.

To provide back up for the accident and emergency medical staff.

To manage patients in the Critical Care Unit where appropriate, and working closely with, colleagues in other disciplines.

To run outpatient clinics and perform OR procedures at Faith Hospital (on our sister island Cayman Brac) monthly.

To develop, along with colleagues in the Cayman Islands Hospital, evidence-based guidelines, and care pathways relevant to the urology service.

To take part in continuing professional development, clinical audit, and quality monitoring. There is an entitlement of 10 days paid study leave per 2-year contract.

To participate in strategic healthcare planning of surgical services. The post holder will be a member of the Medical Staff Committee, Clinical Quality Committee, and Pharmacy and Therapeutics Committee.

To establish, with colleagues, an ongoing education programme for nursing and other staff within the department.


To liaise with other statutory and non-statutory agencies to develop health promotion and disease prevention strategies.

### Qualifications, Experience & Skills Requirement

Must have a primary medical qualification registered in either Canada, the U.S.A., the United Kingdom, or Jamaica, and a minimum of four years training in general surgery as well as a recognized post-graduate qualification e.g., FRCS, MD, Board Certification or equivalent.

At least 7 years postgraduate experience in the specialty relevant to the services provided.

# **Reporting Relationship**



### **Direct reports**

Reports to the Clinical Head of Department.

Postholder may be involved in the supervision and training of returning Caymanian Doctors who are employed in the Department.

Ensuring adequate exposure to general surgical cases and how to deliver evidence base care for interns who rotate through the department.

Postholder guides the nursing staff in the care of the urology patients.
